#### **Qualifications of voters** (115.133, RSMo)

 $\stackrel{\wedge}{\Rightarrow}$ Any citizen of the United States who is a resident of the State of Missouri and seventeen years and six months of age or older shall be entitled to register and to vote in any election which is held on or after his or her eighteenth birthday.

#### What is needed to register (115.135, RSMo)

 $\stackrel{\wedge}{\Rightarrow}$ A person applying to register with an election authority shall identify himself or herself by presenting a copy of a birth certificate, a Native American tribal document, other proof of United States citizenship, a valid Missouri driver's ☆ license or other form of personal identification at the time of registration.

## Change of address/name (115.165 & 115.167, RSMo)

Once voters are registered there is no need to re-register before each election; however, voters may need to update \*\pi their registration periodically if they have had an address or name change. A new voter registration application must be filed with the Scotland County Clerk's Office in order to update the registration. Having the correct address and name on file will ensure that voters are voting in the proper election districts and are easily identifiable when presenting themselves at the polls. Registrations do NOT cross county lines. Voters must re-register if they move to a new county within the ☆state.
